The company has completed the buyback of 6,65,000 equitiy shares of face value of Rs. 10/- representing up to 0.72% of the total number of Equity Shares of the company at a price of Rs. 900/- per 2 Equity shares (including premium of Rs. 890/- per Equity shares) payable in cash for an aggregate amount of up to Rs. 59,85,00,000/- (excluding filing fees payable to the SEBI, advisors' fees, stock exchanges fee for usage of their platform for Buyback, transaction costs viz. brokerage, applicable taxes inter alia including Buyback tax, securities transaction tax, GST, stamp duty, public announcement publication expenses, printing and dispatch expenses and other incidental and related expenses etc.)("Buyback Size") on September 24, 2024. Post buyback Paid up Share Capital of the Company reduced to Rs. 91,27,00,000 divided into 9,12,70,000 Equity Shares of Rs. 10/- each.
